Monday through Thursday ONLY

The Grayson County District Clerk's Office offers passport photo services along with passport processing!

****NOTICE: Due to the unusually large volume of passport customers waiting for applications to be processed, it is necessary to stop accepting applications at 3:30 pm. As a result, we recommend arriving as early as possible to avoid delays.**

Acceptance Hours

Monday – Thursday

8:00 am – 3:30 pm (last application accepted at 3:00pm)

No appointment necessary. Please allow 10-20 minutes for the application process. All applicants need to arrive by 3:00 pm to allow time for processing.

Processing Times

- Routine Service –
 - approximately 10-13 weeks from the time the application is received at the passport agency
- Expedited Service –
 - approximately 7-9 weeks from the time the application is received at the passport agency

Requirements

- Valid Government or State issued photo I.D. for anyone 16 years and older
- Proof of Citizenship
 - Certified Long-Form Birth Certificate
 - Naturalization Certificate
 - Report of Birth Abroad
 - Previously issued fully valid U.S. Passport
- One Passport Photo
 - Photo should be 2"x2" with the head centered and sized between 1" and 1.4"
 - Background is uniform, plain and white or off-white, and free of shadows
 - Photo is clear and in color, reproduces skin tones accurately, and is properly exposed with no shadows
 - Neutral expression is preferred; a natural smile is acceptable
- All Applicants must be present (including children)
- Two Separate Payments for the Fees (see below)

Passport Fees:

- Passport Application Fee - based on age of applicant and the type of processing requested (routine vs. expedite). [Calculate your passport application fee.](#)
- District Clerk Processing Fee - the District Clerk's office charges a \$35 processing fee for each application and \$10(+ tax) for each photo.

REQUIRED FORMS OF PAYMENT

(TWO Separate Fees - Do NOT combine payments)

- **Passport Application Fee**- you must have one of the following forms of payment for each passport application.
 - Acceptable forms of payment: personal check, business check, money order or cashier's check payable to the **U.S. Department of State**
 - Cash or credit/debit cards are **NOT** acceptable forms of payment for your Passport Application Fee.
- 1) **District Clerk Processing Fee** – any form of payment (cash, check, credit/debit) payable to **Grayson County District Clerk**
