#### REQUEST FOR DRIVING SAFETY COURSE/ MOTORCYCLE OPERATOR COURSE – CCP45.051 (B) (2) & (3)

If I decide not to take the Driving Safety Course or Motorcycle Operator Course within the prescribed time, the total fine will be due.

\_\_\_\_\_ I hold a valid Texas Driver's License; that is NOT a CDL, and I have evidence of financial responsibility (insurance coverage).

\_\_\_\_\_ I have not completed an approved Driving Safety Course or Motorcycle Operator Training Course within the 12 months preceding the date of the offense subject to this request, and I am not currently signed up to take an approved Driving Safety Course or Motorcycle Operator Training Course for any other traffic citation which is not yet reflected on my driving record.

\_\_\_\_\_ I understand that I have 90 calendar days from today's date to complete an approved Driving Safety Course or Motorcycle Operator Training Course.

\_\_\_\_\_ I am responsible for returning to this Court, written proof showing that I have completed the Driving Safety Course or Motorcycle Operator Training Course and I hereby promise to present such proof by mail or in person, no later than 90 calendar days from today's date.

\_\_\_\_\_ I understand that I am required to obtain my driving record from the Texas Department Of Public Safety and return that driving record to the Court with the proof of completion of the Driving Safety Course or Motorcycle Operator Training Course.

\_\_\_\_\_ I understand that upon failure to comply with the 90 day provision, I will be required to appear in the Court to "Show Cause" of why I have failed to furnish proof of successful completion of an approved Driving Safety Course or Motorcycle Operator Training Course. I further understand that my case will not be dismissed until the Court receives all of the following; in person, mail, or via email;
